# WCRL 2018 RALLY OBEDIENCE GUIDELINES & REGS SEMINAR

This full day seminar will provide detailed discussion and demos on the NEW 2018 Guidelines and Regulations to WCRL Rally Obedience and will cover the WCRL Levels - Intro, 1, 2, 3, and Veteran.

The morning will focus on a review of performance guidelines and judges' expectations for execution of the new signs, as well as tips for teaching the exercises to your dogs.

The afternoon will provide an opportunity to see new exercises embedded in small courses, and will include eight judged demonstration runs to be executed by teams with functional knowledge of the new signs. Scoring results and rationale will be shared with the group with time for a question/answer session after each demonstration.
